
The IQAC Meeting is held on Saturday, 25th March 2017, at 3.30pm in the Common Staff Room and the following matters were discussed.


Minutes and Resolutions Passed: The following resolutions were passed in the meeting:


Minutes and Resolutions Passed :- The following resolutions were passed after the meeting.
