
g.) An On-Campus Placement arrangement shall be made in the first week of June by sending an invite to Alumni and Bar Associations of Belagani District.

h) A Training Programme for supporting staff will be planned by the NSS Unit of the College.


















4. It was resolved that a Board will be displayed in the College with the composition of the Anti-Sexual Harassment Cell of R. L. Law College, Belagani.
