It was suggested that the said Association will be registered.

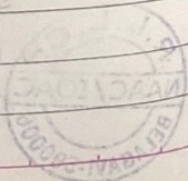
- d) It was decided in the meeting that the Mentor - Mentee meeting will be conducted after the inception of offline classes (May 2020-21).
