



The Compliance Report of the Governing Council Meeting held on 29.5.2020 came to be perused and the same is noted.

RESOLUTION NO.1: Considered the matter of renewal of leased line internet connection to the college. At present RailTel Corporation of India Limited is providing the internet service to the college. The matter is discussed in G.C. and it is opined to renew the leased line internet connection for a further period of one year for 2020-21 (June 2020 to May 2021) at an annual charges of Rs.2,00,000/- (payment is to be made quarterly Rs.50,000/-) the payment is to be made out of internet fees collected from the students. **The matter is sent to Board of Management for approval.**

RESOLUTION NO.2: Considered the matter of utilization of Gymkhana funds of 3 Years LL.B. Course (Aided Section). The matter is discussed in GC and G.C. authorised the Chairman G.C. and Principal to take necessary steps to utilize the unspent Gymkhana Funds.



RESOLUTION NO. (AOM) 3: Discussed the matter of admissions to 5 year B.A.LL.B and 5 year B.B.A., LL.B. Courses for the academic year 2020-21. It is opined to book seats in 5 year LL.B. Courses and an advance amount of Rs.10,000/to be collected from the students and the same is to be adjusted against fees after finalization of the seat. The matter is sent to Board of Management for information.

RESOLUTION NO. (AOM) 4: Considered the requirement of one printer for office. The approximate cost of the same is Rs.15,000/-, the matter is discussed and the Principal is authorized to negotiate with the party and order may be placed to Compute, Belagavi and the payment is to be made out of computer fees account of 3 years LL.B.Course.


