ANTI- RAGGING POLICY

Karnatak Law Society's Raja Lakhamgouda Law College, Belagavi is committed follows a 'Zero-Tolerance Policy' towards ragging in conformity with Supreme Court judgments and directions, UGC Guidelines and State Government Instructions. Any student of this institution accused and found guilty of ragging, will be severely dealt with, in accordance with the Provisions of the Law.

In order to check and monitor as well as taking punitive measures against those found to indulge in ragging of any kind, an Anti-Ragging Committee at the institution level, has been

formed.

The principal is the chairman for the Anti Ragging Cell

and all faculty members are the members of the cell.

The Committee/Cell has been formed as per the mandate of the said UGC (Curbing the Menace of Ragging) Regulation, 2009.

University Grants Commission of India imposed regulations upon Indian universities to help curb ragging and

launched a toll-free 'anti-ragging helpline'.

Accordingly, as directed by the court, instructions have been issued by the regulatory bodies UGC/Karnataka State Law University, Hubballi, for inclusion of the clause in the prospectus regarding punishment of students with expulsion etc. if found guilty of ragging.

Ragging in any form is banned inside and outside the campus. Strict action is taken against persons flouting this rule; no leniency is shown. Suspension and/or withdrawal from the

hostel/ college is the first action against the offender.


The Karnataka Education Act of 1983, ragging is a criminal offense and punishable with one-year imprisonment.



PROHIBITION OF RAGGING IN COLLEGE AND HOSTEL

Ragging is defined and made punishable under the Karnataka Education Act, 1983.

KARNATAKA EDUCATION ACT, 1983

Section 2: Definitions: (29) 'Ragging' means causing, inducing, compelling or forcing a student, whether by way of a practical joke or otherwise, to do any act which detracts from human dignity or violates his person or exposes him to ridicule or to forbear from doing any lawful act, by intimidating, wrongfully restraining, wrongfully confining, or injuring him or by using criminal force to him or by holding out to him any threat of such intimidation, wrongful restraint, wrongful confinement, injury or the use of criminal force.

Section 116: Penalty for Raging: (1) No person who is a student in an educational institution including an institution under the direct management of the University or of the Central Government shall commit ragging.

(2) Any person who contravenes sub-section (1) shall, on conviction, be punished with imprisonment for a term which may extend to one year or with fine which may extend to two thousand rupees or with both.

- 2. In addition to considering it as punishable offence under the said section 116, the said offence shall also be punishable under sections 109, 110, 111, 112, 113, 114, 115, 116, 302, 305, 339, 340, 341, 342, 343, 346, 347, 354, 359, 368, 448, 451 and 506 of the Indian Penal Code entailing inflictment of extreme punishment in terms of Standing Order No. 940 of Director General and Inspector General of Police
- 3. Anyone indulging in ragging is liable to be punished appropriately, including expulsion from institution.
- 4. A Review Committee and Flying Squad have been constituted to prevent ragging in the College Hostel.

COMPLIANCE WITH THE SEXUAL HARASSMENT OF WOMEN AT WORKPLACE (PREVENTION, PROHIBITION AND REDRESSAL) ACT, 2013

What is the PoSH Act?

The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013, commonly referred to as the 'PoSH Act' is an Indian law enacted with the objective of making workplaces safer for women by preventing, prohibiting and redressing acts of sexual harassment against them in the workplace. The law was made effective in the whole of India on December 9, 2013, by the Ministry for Women and Child Development.

- What is 'Sexual Harassment' under the Act?

 Section 2(n) of the Act defines sexual harassment to include the following unwelcome acts:
 - i. Physical contact and sexual advances.
 - ii. A demand or request for sexual favours.
 - iii. Making sexually coloured remarks.
 - iv. Showing pornography.
 - v. Any other unwelcome physical, verbal or non-verbal conduct of sexual nature.

These acts may be considered unwelcome if the woman expresses her discomfort upon the commission of these acts, or does not consent to them. Additionally, the following circumstances may amount to sexual harassment if they are connected with any of the acts or behaviour mentioned above.

- i. Implied or explicit promise of preferential treatment in employment.
- ii. Implied or explicit threat of detrimental treatment in employment.
- iii. Implied or explicit threat about present or future employment status.
- iv. Interference with work or creating an intimidating or offensive or hostile work environment.
- v. Humiliating treatment likely to affect health or safety.

IMPLEMENTATION OF UGC REGULATIONS AGAINST SEXUAL HARASSMENT

- University Grants Commission (Prevention, prohibition and redressal of sexual harassment of women employees and students in higher educational institutions) Regulation, 2015 as notified and brought into force by an official gazette on the 2nd of May, 2016.
- The Regulation marks an important step forward in making higher education more accessible to women students in the country and establishing positive mechanisms like Internal Complaints Committees with elected student representatives in all colleges to address the challenge of sexual harassment and gender-based violence.
- It charges all higher educational institutions with the binding responsibility of "creating its campus free from discrimination, harassment, retaliation or sexual assault at all levels". It further provides an elaborate list of supportive measures, which recognize the compounded vulnerability of students on the basis of "region, class, caste, sexual orientation, minority identity and being differently abled".
- At the same time, the regulations also clearly state that "concern for safety of women students cannot be cited to impose discriminatory rules for women in hostels" and that "campus safety policies should not result in securitization, such as over monitoring or policing or curtailing the freedom of movement, especially for women employees and students".
- It also mandates such important steps as according priority to construction of women's hostels, ensuring reliable public transport, gender sensitive health care infrastructure and counseling, adequate lighting on campuses and sensitization programs with faculty, administrative and security staff among others things.
