#### Perspective plan: 2010-2020

The college prepared a perspective plan for a ten-year period commencing from the academic year 2010-2011 based on the NAAC exit report made in 2009. The following strategies were formulated:-

**1. To Strengthen The Feedback System** - At present, the college regularly collects feedback on the teaching-learning process from all the students on the following parameters - knowledge of the teacher, communication skill, subject expertise, syllabus coverage, punctuality in conducting lectures, etc. In the coming years, we wish to make this process more inclusive by adding two more categories of persons in the feedback system i.e. parents and alumni. On the same lines, we plan to add one more parameter, namely, curriculum to the feedback system. We will ask all the stakeholders about the adequacy and relevancy of and the need for changes in the curriculum. The feedback, thus collected, will be communicated to the affiliating University.


**2. To Add Divisions To The Existing Programmes And Introduce A Post-Graduate Programme** - The college began its functioning in 1939 with the traditional 3-year-LL.B. programme. The college introduced a 5-year-B.A., LL.B. programme in 1998 and recently introduced a 5-year-B.B.A., LL.B. programme in 2009 to keep up with the developments in legal education in the country. We plan to expand the same in the coming decade by adding more divisions to these programmes as and when necessary. We also plan to introduce a 2-year-LL.M. programme after getting the requisite approval from the affiliating University.

**3. To Appoint Additional Teaching Staff Members** - The institution plans to appoint additional teaching staff members, well qualified and experienced, as and when the new divisions are added and the new programme is introduced.

**4. To Augment Infrastructure -**

(a) **Additional Classrooms** - The college plans to add more classrooms to our building to cater to the addition of divisions to our existing programmes and introduction of the new programme.


(b) **Auditorium** - The college intends to build a new state-of-the-art auditorium having 400+ seats which will be a multi-purpose hall catering to all the needs of curricular, co-curricular and extra-curricular departments of the college.

(c) **Moot Court Hall** - Learning and mastering mooting skills are amongst the most important practical skills a law student must acquire. Therefore, to further that cause, the college intends to have a separate and dedicated moot court hall on the college premises.


(d) **Better ICT Tools In Existing Classrooms** - The college plans to refurbish the existing infrastructure in the classrooms by adding modern teaching-learning tools.

(e) **More Cabins For The Teaching Staff Members** - The college plans to add more cabins in the staff room to accommodate all the teaching staff members that we plan to appoint in the near future.

**5. To Enhance The Research Skills** - The college intends to increase the number of seminars, workshops, skill-enhancement courses, etc. organised by it to help the students and the faculty members in polishing their research skills. All the faculty members are highly encouraged to pursue PhD programmes.

6. **To Introduce Add-On Programmes** - The college plans to start add-on programmes especially to benefit the students having a rural background and relatively less knowledge or no knowledge of the English language. Such programmes will contribute a lot to the development of their personalities and soft skills.


7. **To Establish Anti-Sexual Harassment Cell** - The college plans to establish an Anti-Sexual Harassment Cell to take care of the grievances, if any, relating to sexual harassment of everybody, including but not limited to students, and teaching and non-teaching staff members. The Cell would also work to sensitise all the stakeholders regarding these issues.

8. **To Strengthen Alumni Collaborations** - The college plans to have a registered Alumni Association. We further plan to increase special lectures by distinguished alumni which would help in the practical training of the students.

9. **To Motivate Research** - The college plans to have an International Standard Book Number (ISBN) and an International Standard Serial Number (ISSN) for its publications to encourage publications amongst faculty members and students.

To provide quality education and promote excellence of performance.


