The Feedback collected is used to fill the deficiencies found after analyzing the feedback taken from the students, teachers, and alumni. The students are the stakeholders of the institution whose satisfaction is of most concern for the institution. Students are asked whether the curriculum is helping in developing their personality, fulfilling their expectations applicable in their daily life. If any dissatisfaction is found in the feedback then it is discussed in the mentor meetings. The teachers are asked whether present syllabi fulfil the need for legal education, whether maximum legal knowledge can be imparted through present syllabi, about lacunae present in present syllabi, and the topics that can be added to the syllabi. After the feedback of teachers is taken, a deliberate discussion is made on it, if it is found that a particular subject is outdated or has discrepancies then the same is raised and it is discussed in the Principals' Meet at the affiliating University. In the same way, feedback on the curriculum is obtained from alumni and is analyzed. This gives the institution the views of the alumni relating to the syllabus and curriculum. It helps us to understand the position of the curriculum as it existed and the scope of improvement in the curriculum in the present~day scenario.

Suggestions for improvement of the curriculum by stakeholders ~ The syllabus has to be made simple and such subjects should be introduced which are useful from a practice point of view. Students should be prepared for judicial exams. More practical teachings should be adopted such as moot courts and mock trials to give exposure to students and develop communication skills. Procedural law should be emphasized and taught in detail. The course has to be more practical oriented.


Below are some issues identified by the stakeholders which we would like to submit for your kind perusal:

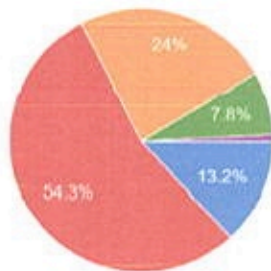

7. Do you agree that the Curriculum (Law Subjects) content is interesting?

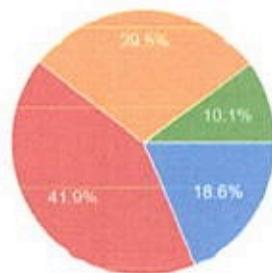

8. Does the Law Course fulfill your expectation?

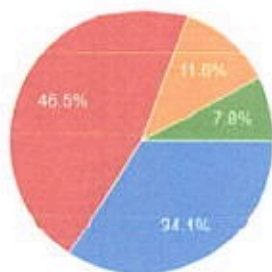

9. Do you agree that the Law Course helps in developing your personality?

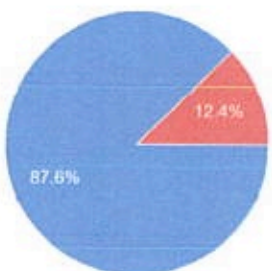

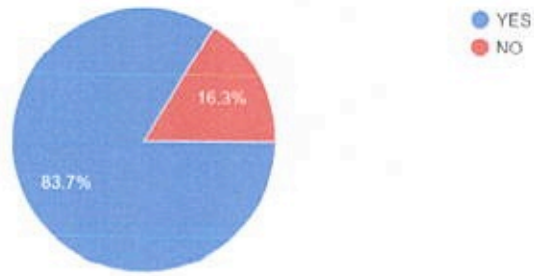

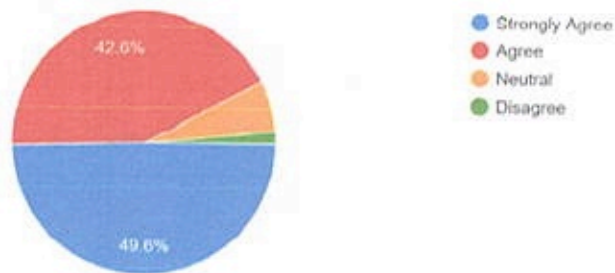
11. Is the Curriculum (Law Subjects) relevant for the solution of local problems?

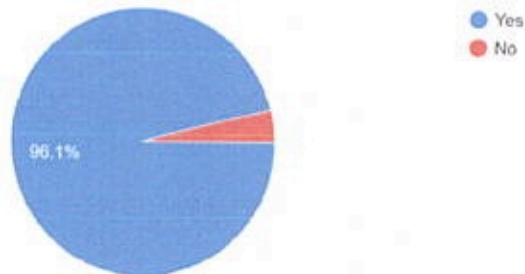
12. Do you agree that Internships are important for Law Course?

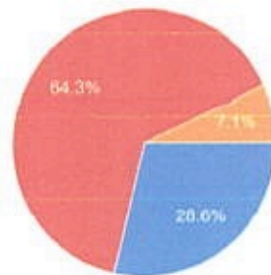

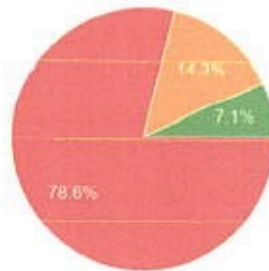

Are the Programme outcomes of the syllabi well defined?

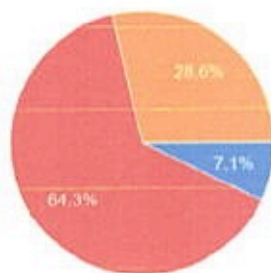

Do you agree that the Curriculum has good academic flexibility?

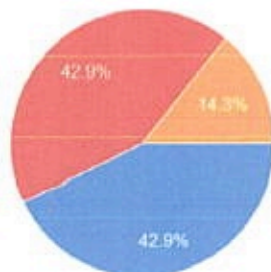

Do you agree that there is a need to review the syllabus?

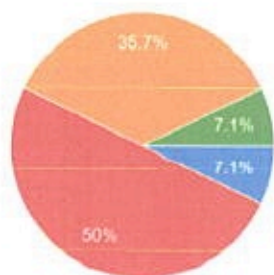

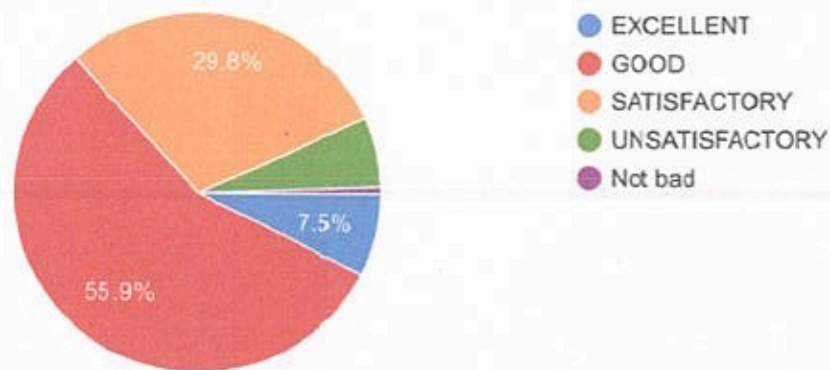
3. Interest generated by Teacher regarding syllabus is

Do you agree that the current syllabus is need based?

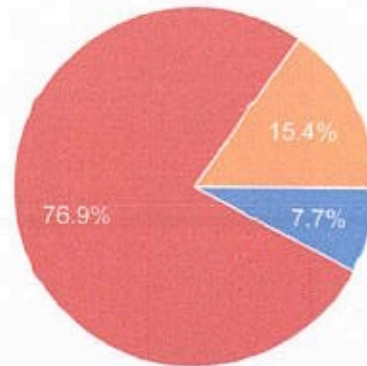

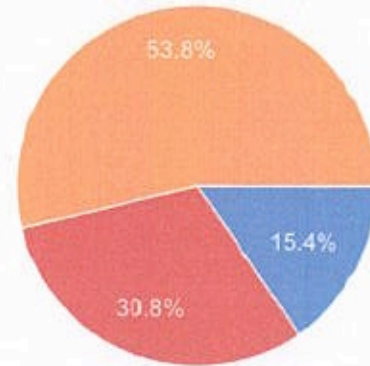

Are the Programme outcomes of the syllabi well defined?

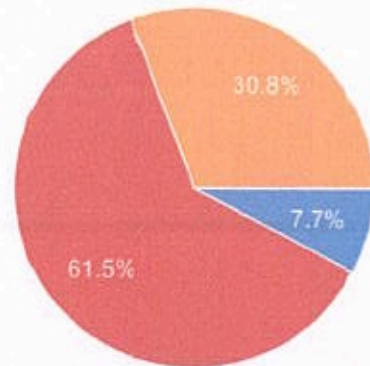

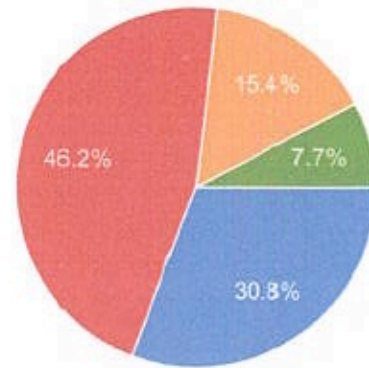

Do you agree that there is a need to review the syllabus?

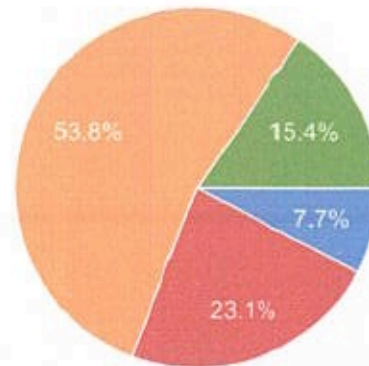
