
Below are some issues identified by the stakeholders which we would like to submit for your kind perusal:

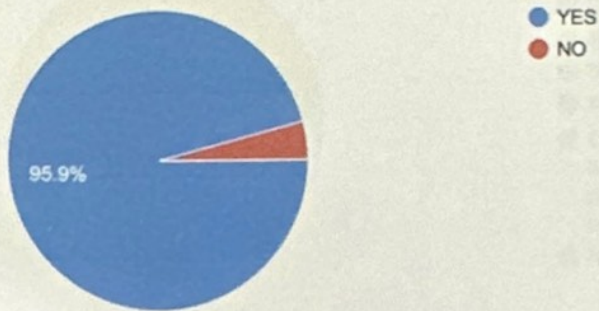
1. Are you aware that the curriculum (Law Subjects) is prescribed by Karnataka State Law University, Hubballi?

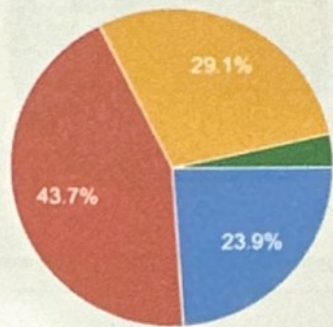

Do you agree that the current syllabus is need based?

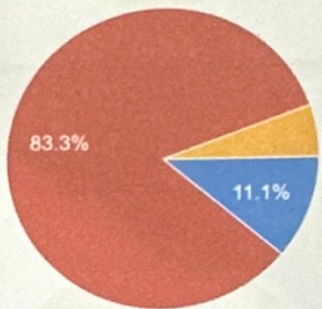



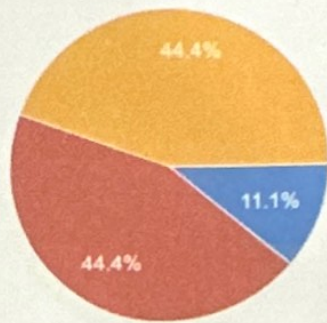

Are the Programme outcomes of the syllabi well defined?

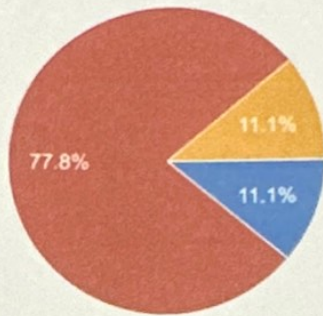

Do you agree that the Curriculum has good academic flexibility?

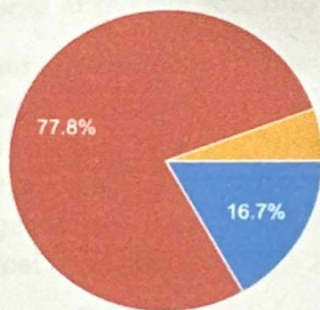

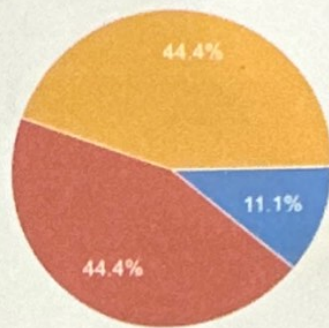

Does the course content fulfill the need of students?

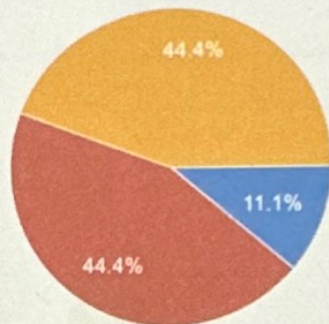


### SUGGESTIONS BY TEACHERS

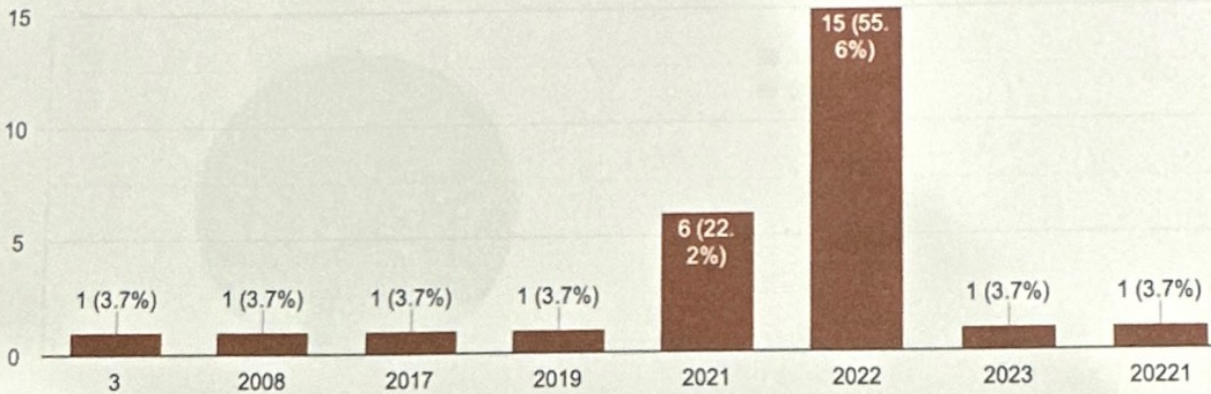

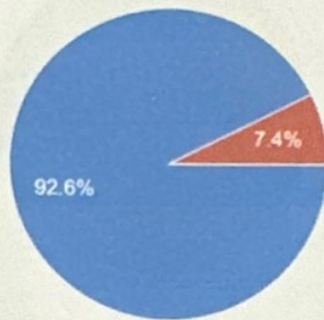

Did the Law Course meet contemporary requirements?

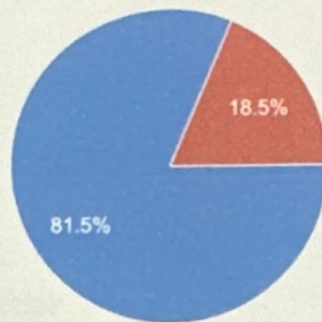

Was the Reading material regarding the curriculum easily available?

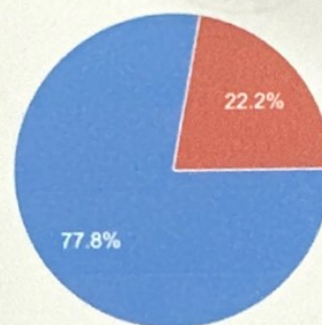




